This waiver is required. Participants that do not submit this waiver signed by themselves (if 18+) or a parent/guardian (if under 18) will not be permitted to participate and this application will not be considered.

In consideration of being permitted to participate in the USA Hobby Horse Championships held on August 1 and 2, 2026 at Legacy Center Sports Complex in Brighton, MI, participant hereby agrees to the following:

Assumption of Risk. Participant acknowledges and understands that participation in the Event involves inherent risks, including but not limited to physical injury, property damage, and emotional distress. Participant assumes all such risks and agrees to hold the US Hobby Horse Championships harmless from any and all claims, demands, losses, or liabilities arising out of or in any way connected with Participant's participation in the Event.

Medical Treatment. Participant agrees to provide for all medical treatment that may be necessary as a result of Participant's participation in the Event. The US Hobby Horse Championships is not responsible for providing any medical treatment to Participant.

Rules and Regulations. Participant agrees to comply with all rules and regulations set forth by the US Hobby Horse Championships for the Event. The US Hobby Horse Championships reserves the right to remove Participant from the Event for any violation of such rules or regulations.

Release and Indemnity.
